CHILDREN & GRANDCHILDREN PLAN

Policies can also be purchased for children and grandchildren ages newborn through 23 for \$1.15/week for a \$10,000 policy or \$2.30/week for a \$20,000 policy.

Premiums are taken care of simply and easily through payroll deductions.

EASY APPLICATION PROCESS

This insurance does not require a medical exam or blood profile. Eligibility for coverage is based on a few simple health questions on the application.

EMERGENCY BURIAL BENEFIT

Within 24 hours after receiving notice of an insured's death, an emergency death benefit of the lesser of 50% of the coverage amount, or \$15,000 will be mailed to the insured's beneficiary, unless the death is within the two-year contestability period and/or under investigation.

TERMINAL ILLNESS

This plan pays the insured 30% (25% in Connecticut & Michigan) of the policy coverage amount in a lump sum upon the occurrence of a terminal condition that will result in a limited life span of less than 12 months.

The coverage amount cannot be individually decreased+ on a particular insured due to a change in age, health, or employment status.*

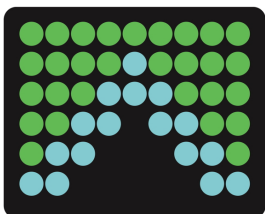
